## Abuse of Officials

The IEOC is sadly being made aware of an increasing number of incidents of abuse of Officials by riders and/or members of their entourage.

It is essential that Officials report any such incidents to the FEI Legal Department using the FEI Incident Report Form. We would encourage you to cc the IEOC ([mail@ieoc.info](mailto:mail@ieoc.info)) if you find yourself in the position of submitting an incident report.

It is important to remember the term “abuse” is generally understood to encompass psychological abuse as well as physical abuse.

<b>Points to note:</b>	Following a disciplinary hearing, the athlete should be informed of the decision. If the athlete is sanctioned, limited facts about the sanction should be published as soon as possible (normally by way of a brief statement). The GJ and TD should also be prepared to answer questions about the legal process and its consequences. However, beyond this, the GJ is not expected to provide detailed information to any of a rider's entourage about the content of a disciplinary hearing after it has taken place.
